

WLN INDEPENDENT AFFILIATE FORM

Introduction. Western Liberty Network (WLN) is a 501(C) 3 non-profit organization dedicated to educating and training on the fundamentals and best practices of grassroots organizing and civic involvement. This application secures a subscription to educational offerings provided by Western Liberty Network (WLN) for the group known as _____, which shall be referred to here as the Independent Affiliate, or "IA".

WLN's Offerings. WLN will develop, collect, organize, and offer educational services, information, materials, products, training, activities, and supporting resources to be made available to IA. WLN will make these offerings known to IA leadership and/or IA rank-and-file members as applicable.

WLN offerings will be designed to teach grass roots volunteers how to participate in local elections as candidates, campaign managers, campaign workers, signature gatherers, and how to run their grass roots organizations more efficiently on a day-to-day basis.

WLN will exclusively engage in educational activities. WLN will not engage in candidate, initiative, or legislative advocacy, although IA may choose to do so as a completely independent organization.

Subscription Period. The subscription period will run until it is terminated by one or both parties from the date an authorized representative of IA has signed this application and sent a copy of it to WLN. The subscription agreement can be terminated at any time by any authorized representative of IA or WLN by written notice.

Relationship Between WLN and IA. WLN and all IA's are independent of each other, and must at all times maintain separateness to protect WLN's non-profit status and the autonomy of the IA. Apart from the terms of subscription outlined in this document the parties have no legal obligations or rights to control one another.

Neither IA or WLN may be a chapter, branch, subdivision, or organ of the other. Neither WLN or IA has policy making authority over the other, has authority of who constitutes the leadership of the other, is responsible for any actions taken or statements made by the other, nor does IA's status as a WLN subscriber impact any affiliations it may have with other individuals or entities.

WLN offerings are intended to augment, not supplant, those of IA and any other organizations IA may affiliate itself with. IA is not obligated to avail itself of any particular WLN offering. The existence of this relationship does not constitute any endorsement by WLN or IA of actions or statements made by the other. *(continued on next page)*



Terms of Service.

1. IA will provide it's rank and file members with timely information about educational and training opportunities offered by WLN. Such information may include such things as event information, the WLN web site address, WLN contact information, the WLN Facebook page, and the like.
2. IA members will be given preferential seating, pricing (where applicable), and full access to WLN services.
3. When possible and practical, if desired by the IA, WLN will provide on-site training at IA's meetings.
4. At least two people will be designated by IA to represent it on periodic conference calls organized, managed, and conducted by WLN. The purpose of these calls will be to update IAs on WLN educational offerings, provide feedback and exchange ideas, prepare for upcoming WLN activities, and share best practices.
5. Two people will be designated by IA to attend an annual WLN leadership conference. These conferences will be held to provide leadership training, update IA leaders on WLN activities, share experiences and best practices, and build personal relationships and an esprit de corps among grass roots activist leaders.
